The scope of work includes reconstruction of approximately 1,320 linear feet of water main, and approximately 1,120 linear feet of drainage pipe, cured in place pipe lining of approximately 1,330 linear feet of sanitary sewer pipe, sidewalks, curbing, and road related improvements. The estimated project cost is \$950,000.00. The contract duration is 120 consecutive days.
