 - The following regulations have been reviewed by the Board; they have been reformatted only and contain no text changes: Tobacco, Floor Drain, Body Art, and Keeping of Animals.
 - Private wells The question re whether a public hearing is needed to add the Agricultural Well paragraph is still being pursued. The Board agreed that the paragraph will not be included, since this will probably not occur in Ayer.
 - > Aquifer protection B. Braley is currently reviewing.
 - > Outdoor Wood Burning Still following up with Fire Chief.
 - Kennels Being drafted.
 - Abandoned property Being drafted.
 - Medication disposal Another resident has inquired re how to dispose of prescription medications following the passing of a relative. R. Terry reviewed with the Board her discussion with the NAHB Director and results of research she has done. In response to the current inquiry, the Board agreed that, if Take Back options are not available, disposal by mixing with kitty litter or coffee grounds would be appropriate for non-narcotic items. M. McMillan will further review this issue. A policy will be drafted with Dan Nason when he becomes available.

- Ken Gikas of Region 2 delivered an updated 2012 Emergency Dispensing System (EDS) Plan. R. Terry will email this updated plan to Board members.
