Bids were received at the Boston Office of First Southwest Co. the Town's financial advisor, Thursday, June 17, 2004 The low bidder Merrill Lynch & Co was the low bidder for the Towns twenty (2) year bond issue \$13,802,000 offering a net interest rate of 4.34%. Mr. Callahan advised the Board to Moodys's Investor Services affirmed the Town's A2 bond rating which reflected the Town's satisfactory financial position, diverse tax base, and manageable debt position as positive credit factors. The bond will be used for sewer, water, fire station construction, land acquisition, equipment, landfill closure, and \$10,208,102.87 of proceeds will be disbursed to pay off our one year Bond Anticipation Note (BAN). The Board moved to accept the Treasurer's report and recommendation and awarded the bid to Merrill Lynch & Co. for \$13,802,000 with interest rate of 4.34%.
