## 1. Fire Station

The Board met with the Fire Station Construction Committee and Project Manager Tony DiLuzio of KV Assoc.-The Committee requested the Selectmen accept the withdrawal of Eastern General's bid with the understanding of the Town keeping the bid deposit and do an alternate bid award to Barr Inc. of Putnam CT. for the contract bid of \$3,997,000.00.
