including wages, expenses, regular debt, debt exclusion, minor capital, indirect costs totaling \$1,338,486 for Fy-03, \$1,402,876 for Fy-04, and 1,342,931 for Fy-05.

Water Miscellaneous Revenues-Ms. Gabree presented Fy-03 actual, Fy-04, & Fy-05 Budgets-depicting revenue generated showing slight decline projected for Fy-05. Ms. Gabree reviewed Water NET Required from rates from 2003-2005 reviewing the Sewer Expenses, Revenues and NET required from State leading up to Water & Sewer proposed rates for Fy-05 which reflected a 17% increase of \$3.73-\$4.36 for residents, \$4.28 -\$5.00 commercial and \$4.87-\$5.70 for SIU's. The Board requested a separate Water & Sewer Rate hearing be conducted and invite industry.

Solid Waste Enterprise Fund-depicted a \$341,402 General Fund subsidy required for Fy-05.

9:45p.m. Chairman Fay called for a motion to close the Fy-05 Budget Public Hearing due to the late time and reconvene the continuation of the Fy-05 Public Hearing to Thursday, March 25, 2004 at 7pm. Motion made by Selectman Morrison, 2nd by Selectman Sullivan VOTE: unanimous, so moved.

Fire Station Ballot Question – The Board approved the Following Ballot Question to appear on the April 26, 2004 Town Election Ballot-Shall the Town of Ayer be allowed to exempt from the Provisions of Proposition two and one half, so called, the amounts required to pay for the bond issued to cover the additional cost to the Fire Station Project? Motion to approve made by Selectman Bresnahan, 2nd by Selectman Morrison, VOTE: Selectman Bresnahan aye, Selectman Morrison aye, Selectman Maxant aye, Selectman Fay aye, Selectman Sullivan no 4-1, so moved.

Park Dept. Sign Request-The Board approved the Park Dept.'s request to place a sign in front of Town Hall re final sign up dates for soccer. Motion to approve made by Selectman Bresnahan, 2nd by Selectman Morrison, VOTE: unanimous, so moved. **Selectman Morrison**-updated the Board to High School Voting Registration held at the High School this week and having a wonderful turnout, thank you extended to Ann Callahan and Susan Sullivan for going up to the High School to help students register. Selectman Morrison also updated the Board to Government Class to conduct a Town wide Voting Registration Day in April 2004 date to be announced.

Selectman Sullivan requesting the DPW clear tree that fell down on the corner of Central Ave. and Sandy Pond Rd... Ms. Scheipers advised to DPW aware of tree and attempting to determine if tree is on Town property or private property.

10:00p.m. Selectman Morrison moved the Town adjourn from Open Session and enter into Executive Session pursuant to MGL Chapter 39 Section 23b, Exemption #3, re: Contract Negotiations IBPO, DPW Clerical Staff Union and JSRoberts-Town Hall Change Orders, and to adjourn from this Executive Session to re-enter into Open Session for the sole purpose of adjourning the meeting, 2nd by Selectman Sullivan VOTE: unanimous, so moved.
