The Board met with Chairman Hamel and Selectman Slarsky, Selectman Miller absent.

The Weekly Warrant was reviewed and approved in the following amount: P/R: \$40,256.45
Exp: \$348,080.55

The Board met with Steven St. Onge and Tina St. Onge re: Temptations Common Victualler's License at 33 Main St., Ayer, Ma.

Mr. St. Onge stated he was before the Board this evening to request permission from the Board to have placed outside his establishment five (5) tables with two (2) chairs each table. Mr. S. Onge stated he had met the Building Inspector's requirement by having insurance coverage of \$2 million liability insurance.

The Board requested Mr. St. Onge get a letter from the Building owner approving this request for outside tables & chairs.

The Board moved to approve the amendment to Temptations current Common Victualler's License to allow outside tables for seating up to ten (10) contingent upon a letter being submitted by the building owner approving this arrangement. The Board stated they are not sanctioning just amending the license. The Board also requested Nashoba Associated Boards of Health be contacted regarding this request as well.

Selectman Slarsky moved the motion 2nd by Chairman Hamel, Vote: unanimous, so moved.

The Board met with Chairman of the Advisory Board regarding the June 13, 1994 Annual Town Meeting Warrant. Mr. Oelfke stated the Advisory Board had met on Sunday, June 12, 1994, to review the warrant prior to the Board endorsement. The Board reviewed the new changes to the warrant: Commission on Disabilities budget increased to \$1,000.00 from \$500.00. Tree Warden reduced by Building Inspector's Budget increased by \$3,000 to contract out for Sealer of Weights & Measures. Parking Tickets Town Clerk's Election Budget increased to reduced by \$500.00. reflect additional elections. The Shirley Tuition being backed out from the Omnibus Article. To include the three (3) Debt \$1,700,000 Grove Pond Water exclusions: Treatment \$260,000 replacement/installation of Townwide water meters, and \$900,000 for the Library Expansion Project.

Chairman Hamel stated her concern that the residents be informed and know early what impacts there could be to Municipal services.
