
TOWN OF AYER PARKS COMMISSION Meeting Minutes of November 17, 2016

APPROVAL OF MEETING MINUTES:

- The minutes of September 15 were approved by unanimous vote.
- The minutes of October 20 were approved by unanimous vote.

PROJECTS:

- J. Thomas reported that the tree warden is offering to give us three trees to be planted on Park's properties. This
 announcement sparked a discussion about where to plant the trees and the Commission agreed that the best place to
 plant them would be Sandy Pond Beach.
- The dump truck is irreparable, so the Park's pickup truck was used to collect leaves. This task was difficult without the dump mechanism, but the truck box was able to hold the leaves from the leaf sacker.

CAPITAL PLANNING:

- J. Mayo reviewed the current capital plan projects that the Ayer Parks Department wants to have funded and the Commissioners discussed which projects should take priority.
- J. Thomas reviewed the feasibility of the three main projects: Maintenance building, perimeter path, and remediation of
 Kiddie Junction. J. Mayo said there should be alternative funding (CPC) available for the path and playground projects.
 The Commissioners need to decide how the projects should be prioritized. J. Thomas said he believed the Commissioners
 should have a survey done for all three. The capital plan should be submitted December 2, 2016.
