Chairman Fay stated that a motion is needed to close the hearing for the Proposed Zoning Bylaw as there is a new hearing for revisions to the proposed bylaw.

At 6:17 PM Ms. Sue Kennedy made a motion to close the public hearing for the Proposed Revisions to the Ayer Zoning Bylaw that was opened in October 2017. Mr. Geof Tillotson seconded. No discussion, Unanimous vote to approve. (4-0)

Public Hearing, New Proposed Revisions to Ayer Zoning Bylaw and Public Hearing, Proposed Solar Bylaw

At 6:19 PM Mr. Geof Tillotson read aloud the hearing notices for both the Proposed Bylaw and the Proposed Solar Bylaw that was published in the Nashoba Voice on Friday January 26<sup>th</sup> and February 2<sup>nd</sup>.

Chairman Fay turned the meeting over to the Town Planner, Mark Archambault who has a presentation that goes over both the proposed Solar and Zoning Bylaw.

February 15, 2018 Planning Board meeting

Mr. Archambault stated that he would start with his presentation for the Solar Bylaw as it is shorter. Mr. Archambault went through his power point presentation that will be used at Town Meeting that goes through the details of the proposed Solar Bylaw that includes both roof mounted and ground mounted solar and allowed zoning districts for both.

At 7:29 Mr. Geof Tillotson read aloud a motion to move Article2, Proposed Solar Bylaw sponsored by the Planning Board to the Board of Selectman to add to the warrant for the Special Town meeting on March 19<sup>th</sup>. Mr. Ken Diskin seconded. No discussion. Unanimous vote to approve. (4-0)
