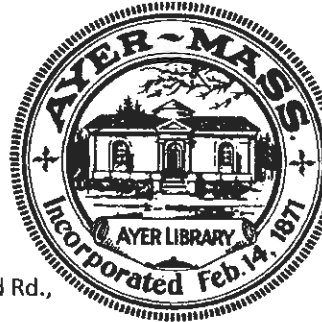


## TOWN OF AYER BOARD OF HEALTH Minutes of July 23, 2018


REVIEW DUMPSTER REGULATIONS: The Board voted to table this discussion until August 27, 2018. A 2/0


NABOH MATERIAL (B. BRALEY): **Wok & Roll:** Following a discussion about the history of this establishment's violations, the Board instructed Chair P. Peters to get in contact with B. Braley to inform her that The Board has given B. Braley and NABOH a directive to do whatever they deem appropriate to rectify the situation. Former Board Member Heather Hasz told the Board that Wok 'N Roll has a history of continual violations of the food code and called for the Board to take "decisive action," saying that food service should be the Board's top priority. **11 Myrick Street:** The debris has been cleared from the yard and the open-cloth dumpster has been removed. **Homeless Encampment:** The Board is waiting for an update from NABOH regarding the encampment at 1 Scully Road abutting Grove Pond.


ADMINISTRATIVE MATTERS: CORRESPONDENCE: A notice sent from the Central Massachusetts Mosquito Control Project announced that the scheduled spraying dates (August 6, 13, 20 and 27) are tentative, and are subject to change due to weather conditions. An E-mail memo from Carly Antonellis dated July 20, 2018, with an attachment from Town Legal Counsel Mark R. Reich, who cautioned against the use of the terms "Special Permit" and "Special Permit Granting Authority," and who explained that "it is important to be sure that the Board of Health regulations do not impermissibly seek to regulate land use, as the Board of Health is not a zoning body." A directive from the MassDEP dated July 19, 2018, acknowledging the receipt of a permit application for a pilot study proposal to evaluate granular activated carbon and anion exchange resin for the removal of Perfluorinated Alkyl Substances (PFAS) from the water at the Grove Street Water Treatment Plant. MISCELLANEOUS: The Board agreed to cancel its August 13 meeting.

ACTION ITEMS FOR AUGUST 27 MEETING: Discussion of issues related to BOH changing responsibilities in matters pertaining to aquifer protection, and review of the Board's Animal Regulation.
