### \*Aver Board of Selectmen Meeting Highlights from March 30, 2020

Due to the ongoing COVID-19 Pandemic and in accordance with Governor Baker's Emergency Order temporarily suspending certain provisions of the Open Meeting Law; Public bodies otherwise governed by the OML are temporarily relieved from the requirement that meetings be held in public places, open and physically accessible to the public, so long as measures are take to ensure public access to the bodies' deliberation "though adequate, alternative means".

- The Ayer BOS Meeting was called to order in Open Session at 6:00pm in the First Floor Meeting Room of the Ayer Town Hall using public remote participation technology which consisted of a live broadcast of the meeting on Channel 8 as well as a live stream on <a href="https://www.ayerpublicaccess.org">www.ayerpublicaccess.org</a>. The Public was instructed to call in remotely to a teleconference number if they wanted to provide any public input or ask any questions.
- The BOS received a Town of Ayer Coronavirus/COVID-19 Preparedness Update from the Town Manager and Police Chief. The Town of Ayer continues to be proactive out of an overabundance of caution with its local preparedness to limit the spread of COVID-19. There is an urgent need for all forms of Personal Protective Equipment (PPE) for the Town's First Responders (Fire, EMT, Police, DPW, and Health Inspectors). - The BOS voted (3-0) on recommendation of the Town Manager in consultation with the Fire Chief and Police Chief; and in accordance with Federal and State directives including the Governor's Emergency Order(s) to amend the Town's Directive regarding the suspension of nonessential Town programs and services which was originally issued on March 14, 2020. The amended directive extends the public closure of all Town Buildings and Town-owned outdoor parks and recreation facilities (including Pirone Park, Sandy Pond Beach, and the Ayer Dog Park) until May 4, 2020.
- Additionally, the amended Town Directive extends the cancellation of all public meetings in Town Buildings through April 7, 2020 (except for the Board of Selectmen and Board of Health). Beginning on April 8, the Town will begin to implement remote public participation meetings for other Town Boards, Committees, and Commissions in accordance with the Governor's Emergency Open Meeting Law Order and on a priority basis. - The BOS conducting the Public Hearing for the Adoption of the FY 2021 Water and Sewer Rate Recommendations. The DPW Superintendent made the presentation on behalf of the Town's Rate Review Committee. The BOS voted (3-0) to approve the following recommendations as presented and recommended by the Rate Review Committee:
