Public Input

Selectmen Maxant requested a brief public input item. Selectman Bresnahan moved and Selectman Sullivan seconded to accept agenda with the addition of one public input item. Vote – unanimous, so moved.

Selectman Maxant commended Chairman of the Board of Selectmen Faye Morrison and Vice-Chair Connie Sullivan for their sensitive and efficient handling of the Town's response to the community concerns in the wake of the death of Kelly Proctor. Selectman Maxant also thanked the Proctor family for response to the issues of community concern.

Agenda Item 1. Reserve Fund Transfers:

- 1) Communications Commission Selectman Bresnahan moved and Selectman. Conley seconded to approve a transfer to the Communication Committee account in the sum of \$320. Vote unanimous, so moved..
- 2) DPW Fuel Account Supt. Madigan stated he wished to withdraw his request for a transfer. It was determined not to be needed.
- 3) Ambulance Accounts Selectman Conley moved and Selectman Maxant seconded to approve a transfer for ambulance accounts 64220/5300 and 64220/5500 in the total amount of \$1427.07. Vote unanimous, so moved.
- 4) Public Buildings Selectman Conley moved and Selectman Maxant seconded to approve a transfer for the public buildings account in the amount of \$3,329.51. Vote unanimous, so moved.
- 5) Town Counsel Legal Services: Selectman Conley presented a summary of reduction she felt should be made to the transfer amount based on charges that should be charged to the Community Preservation account or to not be paid at all. Copy attached.

Building Inspector, Alternate Building Inspector—with terms to expire on June 30, 2006 as listed on Page One and Page Two of the document entitled "FY06 Appointments". Vote—unanimous, so moved.

Selectman Conley moved and Selectman Bresnahan seconded to appoint Roberta L. Chase to the position of Asst. Tax Collector for the term of July 1 2005 ending June 30, 2006. Vote – all yes.
