9:00A.M. OPEN SESSION

THE BOARD MET WITH CHAIRMAN SLARSKY, SELECTMAN MCKINNEY AND SELECTMAN JONES.

THE BOARD MET WITH SUPT. REDFIELD, RE: PENDING WATER TIE-IN APPLICATIONS. ALSO PRESENT FOR THE DISCUSSION WERE TOWN COUNSEL, AND CONTRACTOR, GEORGE CARPENTER. CONTINUING DISCUSSION FROM MONDAY, MARCH 4, 1991.

CHAIRMAN SLARSKY READ INTO THE RECORD THE DECEMBER 14, 1990 EMERGENCY WATER DECLARATION. THE BOARD DISCUSSED THE ISSUE AT HAND-HOW TO HANDLE APPLICATIONS THAT WERE SUBMITTED PRIOR TO DECEMBER 14, 1990.

TOWN COUNSEL, ROBERT GARDNER STATED THAT HE HAD SPOKE TO JOHN FULLER OF DEP WHO STATED THAT THE TOWN COULD APPROVE ANY TIE-INS SUBMITTED PRIOR TO DECEMBER 14, 1990, BUT TOWN COUNSEL STRONGLY RECOMMENDS GETTING THIS IN WRITING FROM MR. FULLER STATING TO THAT EFFECT.

CHAIRMAN SLARSKY REQUESTED A LIST OF THOSE APPLICANTS WHO HAD SUBMITTED PRIOR TO 12/14/90 BE PRESENTED TO THE BOARD AS SOON AS POSSIBLE.

SELECTMAN JONES WAS CONCERNED THAT THE BOARD NOT VIOLATE THE MORATORIUM.

THE BOARD MOVED TO GET WRITTEN DOCUMENTATION FROM DEP FOR CONFIRMATION OF APPROVAL TO RELEASE TIE-IN APPLICATIONS SUBMITTED PRIOR TO THE 12/14/90 WATER EMERGENCY DECLARATION. SELECTMAN JONES MOVED THE MOTION, SECONDED BY SELECTMAN MCKINNEY, VOTE: UNANIMOUS, SO MOVED.

MECHANICS POSITION-DPW (CONTINUING DISCUSSION FROM 3/4/91)

THE BOARD REQUESTED SUPT. REDFIELD BRING THE TOP APPLICANT TO THE NEXT SELECTMEN'S MEETING SCHEDULED FOR 3/18/91 AND INTRODUCE HIM TO THE BOARD.

THE BOARD MET WITH FIRE CHIEF WELLMAN PARKER REGARDING THE BID AWARD FOR THE UNDERGROUND FIRE ALARM SYSTEM. CHIEF PARKER RECOMMENDED THE BOARD AWARD THE BID TO THE LOW BIDDER R.B. ALLEN FOR THE BID AWARD OF \$4,837.00. SELECTMAN JONES MOVED THE BOARD

AWARD THE BID FOR THE UNDERGROUND FIRE ALARM SYSTEM BE AWARDED TO R.B. ALLEN FOR THE BID PRICE OF \$4,837.00 AND TO APPROVE THE FUNDING FOR THIS PROJECT BE TAKEN FROM THE WEST MAIN STREET REVITALIZATION ACCOUNT, SECONDED BY SELECTMAN MCKINNEY, VOTE: UNANIMOUS, SO MOVED.



THE BOARD MOVED TO SUPPORT THE MASSACHUSETTS MUNICIPAL ASSOCIATIONS INITIATIVE NOT TO CUT LOCAL AID BY SIGNING PLEDGE CARDS TO BE SUBMITTED TO LOCAL REPRESENTATIVES TO ENDORSE THEIR ADVOCATING OF THE SAME.
