- Approval of Meeting Minutes

#### <u>NEW BUSINESS</u>

#### • Discussion: Boards and Commissioners training session

- JP represented both CPC and Ayer Housing Authority at a training session, on 11/28,2017, held in Boston by the State.
  - She will circulate an informational flyer from the session once the State puts it on line.

#### • Discussion: CPC Success Stories

- JP has compiled a list from the Community Preservation Coalition's database of all of the CPC-funded projects approved by the Town since the formation of the CPC in 2001.
  - JP has prepared blurbs with accompanying photos for a few of them, for use in a CPC informational brochure as well as for use on social media, such as CPC's website and the Town's Facebook page.
  - JP asked CPC members to help in preparing these blurbs and the list was divvied up accordingly.
    - Where possible, the blurbs will be grouped according to the CPA categories: Historic, Housing, Open Space, and Parks & Recreation.
  - CPC projects, fully or partially funded, through the years include:
    - restoration of the Town Hall roof (2005) and installation of the Town Hall emergency generator (2011);
    - Pleasant Street School emergency generator (2017);
    - Sandy Pond School Association's Conditions Assessment (2016)
    - construction of Habitat for Humanity houses (2004, Shirley Street; 2014, Central Avenue);
    - historic resources inventory for Historic Commission (2001);
    - renovation and affordable housing associated with the Pleasant Street School/Ayer Elderly Housing Partnership (2007) and adjacent pocket park (2011);
    - historical restoration of the Fletcher (Nutting) Building (2011);
    - Greenway Committee projects (signs, kiosks, trail work, etc.);

- Open Space purchase of the Tooker property (2009);
- pond management projects, including invasive weed control, support for the Pond & Dam Management Committee, support for the Geosyntec biological survey and assessment of Ayer's ponds (2011, 2014);
- Paige-Hilltop School fence (2002);
- establishment of a Conservation Fund (2017);
- Sandy Pond Town Beach projects, including ADA compliance (2002, 2003, 2005);
- restoration of historic Fire Department photos (2015);
- funding in support of Open Space & Recreation Plan update (2015);
- Pirone Park projects for irrigation (2005) and perimeter path (in process, 2017);
- community dog park (in process, 2017);
- historical renovation of Central Fire Station roof/cupola (in process, 2017).
- Should CPC ask the Town to approve a hike in the CPA surcharge from 1% to 3% (which was where Ayer CPC began in 2001), these blurbs will be useful for informing residents as to how their contributions to the CPC are used.
  - (Note: the higher surcharge of 3% results in a larger percentage support of matching funds from the State.)
  - To date, CPC has spent approximately \$2.2 million on these varied community projects.
- JP asked for each member to have their blurbs prepared by the time of CPC's February 2018 meeting.
