Project Location



Project Overview

- Provide a "Gateway" to downtown Ayer
- Full depth reclamation and repaving of roadway
- Granite curbing with new concrete sidewalks and driveway aprons
- Realignment of intersections to enhance sight distance
 / improve safety
- Output Dedicated bike lane on each side of street
- Replace drainage system

Project Funding and Schedule

- Project is being designed and constructed as a Federal Highway Transportation Improvement Project
- Project design funded by Ayer Town Meeting Appropriation and designed to meet MassDOT requirements
- Construction will be funded and managed by MassDOT
- Right of Way process Sept through March, 2020
- MassDOT Bid- April and May 2020
- Construction staring Fall 2020 with completion Summer 2021

Road Issues



Poor Pavement Condition

- Multiple trench patches
- Localized pavement failure around utility structures



Substandard Pedestrian Network

- Lack of ADA compliant wheelchair ramps
- **Crosswalks poorly defined**
 - Midblock crossings lack advanced warning signs Inconsistent sidewalk materials
- Sidewalk cross slopes exceed standards _
- Obstructions in path of travel _

Project Issues



Drainage System Deficiencies

- Localized pavement failure around structures
- Majority of structures filled with sediment
- System outlets to adjacent waterbodies



Intersection Geometry

- Poor intersection sight distance
- Undefined paths of travel

New Road Layout



Right of Way Process

Very specific and documented process

- Perform Title search
- Finalize Right of Way / Easement Plans
- Notify Property Owners
- Meet with property owners to discuss property specifics
- Hire Appraiser and Review Appraiser to determine "just compensation"
- Provide written offer you have 30 days to accept the offer
- BOS vote property acquisitions and awards
- Pay property owners
- Documents are recorded with Registry of Deeds


Consider Donation of Temporary Easement

- Project will enhance your property and the "livability" of the Town
- Reduces financial burden on Town
 - Town is responsible for payment of temporary easement awards
- Expedites the project
 - Fewer properties requiring appraisals
- Certificate of Donation Form available

Easements

 60 Temporary Construction Easements – Permission to enter property

- Required to construct sidewalks, driveway aprons and walkways
- Match existing grades between sidewalk and lawn, driveway and walkways
- 4 Permanent Easements Permanent easements will be required to ensure the adjacent sidewalk / wheelchair ramps are located within the public Right of Way
 - 2 Utility related
 - Livingston Street is not within layout (3 to 5 feet)
 - Pond Street Sidewalk is not within the layout

 Appraisals will start in November. Appraiser will contact you and you have the opportunity to provide information and accompany them on the inspection of the property

• What if you are not satisfied with the amount of award?

- You can provide additional information and Town will reconsider amount
- If still not satisfied, can file suit against Town

 - During construction, we will provide weekly updates via email and Town web page
