Review, ANR 0 Bligh Street

Present: Cal Goldsmith, GPR, Inc.

Mr. Cal Goldsmith, Engineer/Presentative for the applicant, presented to the Board the assessors' map; showing the property in question. Mr. Goldsmith gave a brief explanation of the property's history and layout. Mr. Goldsmith went over the proposed ANR plan which includes part of Grove Pond. The owner of the property is selling it to a new buyer which is not interested in the Grove Pond section. The ANR will separate the Grove Pond back area from the front part of the property. The proposed Lot B will have a small section that connects to Bligh Street and the current owner will retain Lot B and the new owner will have Lot A.

Mr. Nathan King asked if the deeded right of way is created on the parcel will it come to the Board in a Site Plan application.

Mr. Goldsmith stated that the right of way would be part of site plan, that the Board will review, if it is created as part of the agreement of the sale.

Mr. Ken Diskin had a question on note #3, requesting more detail as well as a question on the note above the signature block.

Mr. Goldsmith went over note #3 limit of use due to DEP involvement from the site being filled.

Mr. Goldsmith stated that the note above the signature block is on all their plans and that it simply protects the Planning Board by stating that the plan is only being created and does not need subdivision approval.

At 6:36 Mr. Ken Diskin made a motion to endorse the ANR plan for 0 Bligh Street titled Plan of Land, 0 Bligh Street creating lot a and b dated April 12, 2023. Mr. Nathan King second. Vote to approve by roll call vote: Mr. Nathan King, aye; Mr. Ken Diskin, aye; Ms. Julie Murray, aye; and Chairman Kranz, aye.
