***Ayer Select Board Meeting Highlights from October 3, 2023**

This meeting of the Ayer Select Board was held in-person at the Ayer Town Hall with a remote participation option on Zoom for the Public.

- The Select Board (SB) Meeting was called to order at 6:00pm in Open Session.
- The SB voted (3-0) to approve the layout of Curley Circle as a public way subject to approval by Town Meeting on October 23, 2023. The SB voted (3-0) on recommendation of the DPW Director to execute the contract in the amount of \$1,743,160 to Vortex Services, LLC for the Sandy Pond Sanitary Sewer Rehabilitation Project.
- The SB interviewed candidates for the five (5) Resident positions on the Senior Center Site Selection and Building Committee. The SB voted (3-0) to appoint David Cibor, Dave Grubb, Ellen FitzPatrick, Carolyn McCreary, and Chris Prehl to the five (5) Resident positions on the Senior Center Site Selection and Building Committee. *

**Note: In addition to the five (5) Resident positions, the Committee is composed of the COA/ Senior Center Director; DPW Director; Ken Diskin (Planning Board Representative and Resident); and Dennis Curran (COA Representative and Resident for a total of nine (9) members of the Committee.*

- The SB reviewed and voted (3-0) to approve the Fall Special Town Meeting Warrant for October 23, 2023. *

The Fall Special Town Meeting will take place at 7pm on Monday, October 23, 2023 in the Auditorium of the Ayer Shirley Regional High School.*

- The SB received an Administrative Update from the Town Manager. The SB voted (3-0) approve the Keno Application for Pleasant Café, Inc. located at 7 Depot Square in Ayer. The SB voted (3-0) to authorize a 25% reduction in cost for the following 2024 annual license renewal fees: Class 1-3 Auto; Liquor Licenses; Common Victualler's; Entertainment; and Amusement Licenses.
- The SB voted (3-0) to approve the meeting minutes from September 6, 2023.

- The SB voted (3-0) to adjourn the meeting at 6:50pm.
