- Confirmation of Agenda
 - o J. Murray moved to confirm the agenda as posted; B. Schwarzel 2nd.
 - Motion approved unanimously by Roll Call Vote 6-0

 - Motion approved unanimously by Roll Call Vote
- B. Suedmeyer moved approval of minutes for the 9/28 Public Hearing for the Howitzer restoration project; B. Schwarzel seconded the motion
 - The motion was approved by a roll call vote; 4-0 (2 abstentions)

 - There will be 4 warrants at the Fall Town Meeting; two of those warrants are CPC proposals
 - For the Ayer Commons Project, J. Providakes will share her presentation to the Zoning Board of Appeals at Town Meeting
 - The Howitzer Restoration project is the other project requesting CPC funding
- o 0 High Street Update
 - The appraisal for the property came in at 780K and the selling price for the 7.39 acre property is 1.2 million
 - The appraisal has been provided to the seller at their request

- The highest/best use of the property according to the appraisal would be affordable housing at the top end of the property and Open Space/Recreation on the remaining portion of the property
- There was a question about the next steps if the seller approves of the appraised value for sale
- Sandy Pond School Association Project Update (this followed committee reports)
 - Irv Rockwood from the Sandy Pond School Association presented an update on the restoration of the school house.
 - Roofers began work on 10/3 on the roof; the old roof was removed and the west side has been reshingled with wooden cedar shingles in alignment with the Department of Interior Standards; the rest of the roof will be completed by next week
 - The cost of the roof was higher than anticipated due to an increase in materials cost; originally quoted at 45K and now 67.5K will be the cost
 - Work in the Ell has also progressed; there is a new opening in the rear accessible entrance
 - The washroom wall has been removed and reframed to make the washroom accessible; new fixtures have been installed and additional plumbing work is needed (a 9K quote has been received and they are waiting on additional quotes)
 - The structure of the Ell has also been strengthened
 - The opening between the classroom and the Ell has been widened to 36" to increase accessibility
 - There has also been restoration work on the windows; they were removed, stripped, re-glazed, repaired and re-installed
 - There will be a third grade visitation program that has been funded by the Ayer Education Foundation; each year third graders from Page Hilltop will be brought to the Sandy Pond Schoolhouse for an immersive experience on what it would have been like to attend school
 - There was some additional discussion about adding parking spaces to the Schoolhouse properties and they are exploring some ideas on how to do this
 - The next update will be provided to the committee in January
