### <u>Item No. 3.:</u> Fueling Station clarifications

Concrete pad is to remain at the existing fueling station. Existing Concrete barriers will be removed and replaced with bollards by the owner.

## Item No. 4.: MBE/WBE Requirements:

MBE/WBE representation is not a requirement. A reasonable representation of both MBE and WBE firm participation with a combined goal of 10.4% is desired, but not a requirement.

# <u>Item No. 5.:</u> ADD THE FOLLOWING TO SECTION 012300 - ALTERNATES ALTERNATE NO. 4 (DEDUCT)

State the amount to be deducted from the contract sum for the substitution of a Pre-Engineered building that meets the design criteria of the Construction Documents. Design Criteria include the following but are not limited to:

- 1. Building Dimensions and Geometry.
  - a. Roof Slopes may be adjusted as required.

- b. 14'-0" height clearance and clear-spans required.
- 2. Door sizes, locations, types, hardware, etc.
- 3. Alternative wall/roof designs will be accepted that meet the gauge thickness, finish type, structural integrity, weather protection and Thermal values.
  - a. Exterior metal sheathing, cavity insulation, and interior sheathing is acceptable.
  - b. Alternative Wall/roof designs to be coordinated with MEP.
- 4. Awnings may be substituted for alternate designs to comply with Pre-Engineered building requirements.
- 5. Must comply with design criteria of an "As-equal" substitution with the products in the specifications.
- 6. MEP Filed Sub Bids are to be included in Bids including Pre-Engineered Metal Buildings.
  - a. MEP scope to be maintained as shown on the Bid Documents.

All other portions of the Contract Documents remain <u>unchanged</u>. Please be reminded to acknowledge this Addendum on the bid forms.
