

INVITATION TO BID

Sealed bids must be submitted to the Department of Public Works, 25 Brook Street, Ayer, MA 01432 by **June 14, 2016 at 11:00 AM**, where and when they will be publicly opened.

All bids must be clearly marked on the outside of the envelope with **“Town of Ayer 2016 Surplus Vehicles & Equipment Sale”** and inside must contain the item number for which each bid is placed, the amount of the bid and the name and address of the bidder.

All bidders must execute a certificate of non-collusion which is provided as part of these bid documents.

All items are available for inspection Monday through Friday during the hours of 7:00 a.m. to 3:00 p.m. at the Public Works Garage at 25 Brook Street. All items are sold “AS IS” without warranties of any kind, and fitness for a particular purpose, and most are in need of some repairs.

The surplus vehicles and / or equipment will be awarded to the responsive bidder offering the highest price for the items described in the invitation for bids. The Town of Ayer reserves the right to reject any and all bids and dispose of the vehicle through a negotiated sale, provided that the negotiated sale price is higher than the highest bid received from a responsive bidder.

Successful bidders are expected to render payment made by cash or bank check payable to the Town of Ayer, in full and collect their purchases within five (5) days of notification of bid acceptance.
