Below is a summary of the Ayer DPW's operations for the month of June. In addition to the items below, there are many ongoing projects in various stages that the DPW staff are involved with. If additional detail or information is needed, please let us know.

Administration

- Completed engineering inspection of West Main Street stone culvert
- Completed engineering inspection of Balch Pond Dam, Balch Pond Dike and submitted reports to DCR
- Submitted grant application for Energy Conservation at Wastewater Pumping Stations
- Quarterly water and sewer bills were prepared and sent out
- Processed and approved Road Opening Permits, Trench Permits and Water & Sewer Connection Permits
- Continued GIS Utility mapping with concentration on including water and sewer connection data
- Attended Trench Safety / Permitting Seminar
- Completed Engineering review of 15 Littleton Road Gas Station Site Plan
- Prepared detailed schedule for implementation of DPW FY16 projects
- Met with MassDOT District 3 to discuss East Main Street Reconstruction, Main Street Bridge, Fitchburg Rd and other DOT related issues
- Began design of Transfer Station site improvements, Washington St Water Main replacement and Wastewater Telemetry System
- Working on Unaccepted Road prioritization plan
- End of Fiscal Year close-outs

Highway Division

- Repaired / rebuilt 5 catch basins

- Completed drainage upgrade project on Jackson Street (1 new catch basin, repaired 3 catch basins and installed 400 feet of replacement drain pipe)
- Repaired damaged drain pipe on Grosvenor St
- Repaired / replaced 6 signs in East End neighborhood
- Trimmed brush and branches at intersections
- Street sweeping on Main Street
- Painted crosswalks
- Performed beaver dam debris removal at the usual locations

Water Division

- Performed daily operations, laboratory testing and reporting for WWTP
