**Re:** November Monthly Report

During the month of November 2016 the Police Department logged 704 events requiring 44 incident reports and 13 arrest reports. We assisted the Fire Department on 50 medicals and 9 fire alarms. Here are some of the highlights:

## November 2016 Monthly Report

On the 13<sup>th</sup> we provided traffic control for a World Kindness Day event that was held on Main Street.

At the BOS meeting on 11/15 we received appointments for David Lansing as a Patrol Officer and Linda Taylor as a Prisoner Watcher. Linda will begin her training immediately and David will begin his on his first day in December.

Lt. Gill and I met this month with the President and the COO of Alternative Perspectives, Inc. concerning their takeover of the operation of the Shriver Job Corps Center. Officially the takeover will occur in early December with no challenges foreseen for the Town.

On the 21<sup>st</sup> Lt. Gill and I met with Justice Cremens and the Clerk of Ayer District Court Wendy Wilton to discuss general topics of interest between our two entities as well as some that concern all the towns serviced by the court.

On the 17<sup>th</sup> and 18<sup>th</sup> I attended a Train the Trainer certification class on a new First Line Supervisor training course. Over the years the MPTC has provided this training to new Sergeants as they assume their duties. This new program is fresh, innovative, and gives these new supervisors the tools necessary to better deal with the more important people side of their new assignments rather than the nitty gritty of daily routine. With this certification I will be able to instruct this class for the MPTC at their academies.

Other training classes attended by officers of the department, either collectively or individually, were in the areas of:

In total the Department spent 180 hours in training for the month.
