Re: May Monthly Report



During the month of May 2018 the Police Department logged 1020 events requiring 46 incident reports and 8 arrest reports. We assisted the Fire Department on 91 medicals and 11fire alarms. Here are some of the highlights:

Radio Follow-up: Timberline has started work at the hospital, since it's inside work, to install equipment that will boost reception inside the building. Tower sites visits were completed and all areas marked out for construction. Materials are on order.

The regionalization of Communications with the Town of Shirley is proceeding. On May 25 we became the Regional Emergency Communications Center for the Towns of Ayer and Shirley. There still some aspects of the transition that will not be completed until November 2018 but there are work arounds in place that will carry us to that date.

May 2018 Monthly Report

On the 8th I attended a quarterly meeting of the Middlesex County Chiefs of Police. During these meetings we are addressed by several representatives of State organizations, such as the DA, Sherriff, DCJIS, etc., and receive respective updates to laws and other procedures that are specific to Middlesex County.

On the 10th the PD hosted a meeting I called of the Downtown Businesses Owners and key Department Heads to discuss issues of parking. Superintendent Wetzel outlined a plan that will be implemented in the near future and many of the questions and concerns of the owners were addressed.

On the 16th we sent SRO Bigelow to Tewksbury to assist with a Car Seat Checkpoint. The SRO is also a Certified Car Seat Installer/Inspector. She will provide services to any citizen who requests it and is part of a team of area towns that conduct Checkpoints yearly.

This month I attended a meeting of the Massachusetts Chiefs of Police Association. These twice yearly meetings are similar to the Middlesex specific meeting except that issues relating to the entire state are discussed.

On the 31st we participated in the Page Hilltop Schools "Touch a Truck" event. During this event Town departments showcase some of their apparatus and children are allowed to move about them and operate non-hazardous controls, such as lights and sirens. This is always a fantastic event that not only allows the kids to "play" with our tools but to also interact with the adults that run them.
