During the month of August 2018 the Police Department logged 716 events requiring 31 incident reports and 11 arrest reports. We assisted the Fire Department on 57 medicals and 8 fire alarms. Here are some of the highlights:

August 2018 Monthly Report

On the 6th Deputy Gill, Detectives Barhight and Kularski, and SRO Bigelow participated in the annual Cops for Kids with Cancer Golf Tournament fundraiser.

Deputy Gill and Detective Barhight attended TriTech Barcoding training in preparation for the upcoming upgrade of our Evidence Room. With the gracious approval of Town Meeting for the Capital funds to upgrade the physical structure of the Evidence Room we are also improving the documentation and tracking of evidence using a barcoding system linked to our Records keeping software.

On the 16th, SRO Bigelow, Deputy Gill, Sergeant Edmonds, Officer Harty, and I were invited to a Picnic with Police at the Ayer Kiddie Depot. We had a great time answering some very good questions from the youngsters while serving up popsicles to go along with their lunches.

During the last week of the month Deputy Gill, Communications Supervisor Herrstrom, Detective Kularski, and members of the Ayer Fire Department attended a TriTech CAD Police/Fire/EMS training. This required training was in preparation for the completion of Phase 2 of the Communications Regionalization.

On the 30th Deputy Gill and Communications Supervisor Herrstrom interviewed candidates for our open Communicator position (a vacancy created with the retirement of Judy Hadley). We hope to have a finalist vetted and ready for appointment later in September.

In total the Department spent 54 hours in training for the month.
