During the month of December 2019 the Police Department logged 594 events. We assisted the Fire Department on 61 medicals and 10 other Fire Department related calls. Here are some of the highlights:

On the 17th Deputy Gill and I joined our COIN communities and many other interested organizations in a full day Sequential Intercept Mapping Workshop held at the Groton Inn. This successful workshop was designed to create a map of steps in getting to a new way of looking at and dealing with Crisis Intervention, both drug and mental health related. We identified our top three goals, and many sub goals, and will be focusing on their completion in the coming months/years.
