During the month of January 2020 the Police Department logged 761 events. We assisted the Fire Department on 64 medicals and 13 other Fire Department related calls. Here are some of the highlights:

The Department continues on in its effort toward Certification. With the assistance of our consultant we have completed the first round of reviewing all Standards and are going back to make noted corrections. We remain on track to be assessed sometime later this year.

SRO Bigelow and Detective Barhight attended the 3rd annual Josephine A. Gazzola symposium

on Advancing and Supporting Women in Law Enforcement this month. The intent of the conference is to bring in speakers and discuss topics that are geared for developing women as future law enforcement leaders. As part of this, female officers also have the opportunity to meet on topics of concern and interest and to develop new professional contacts with the opportunity for mentorship. This is our second year of participation and I am grateful that we are able to send our officers.

Deputy Gill and I attended Critical Incident Management System (CIMS) training this month. CIMS is a software product developed to support countywide police led programs intending to document all overdose incidents within county jurisdictions, document all outreach attempts to individuals who have overdosed or are at-risk for overdose, and facilitate the transition of those experiencing drug overdoses to treatment. The system was developed with several core principals in mind:

- Only collect necessary and critical project related data.
- Make data entry user-friendly, quick, and easy.
- Provide agencies with real time access to some of their most important data.
- Effortlessly share data between jurisdictions.

Once all Middlesex County municipalities have been trained the system will go live and we will be able to not only input future data but also backfill any past data.
