- We are continuing with our CV19 way of life here at the Council on Aging. The Month of May was a very busy month. We are following all levels of protocol issues by the town and the state.
- I submitted all of my paperwork to the Retirement Board of Massachusetts. I have decided to retire and my last day of service will be July 2, 2021 which is the same date in which I began at the COA in the year 2000. It has been an adventure building the Ayer COA. Lots of ups and many downs but through it all I never thought of this as a JOB. I love my town and everyone I have been blessed to work along -side of for all these years. I have no regrets as I begin my new chapter of life. I have done the circle of life (from teaching kindergarten to the COA) in the Town of Ayer and it feels pretty good.
- We are continuing our **daily** Transportation with our MART Van Service! At this time we are now permitted to have 4 folks ride the van at the same time with CV19 protocol still in place. Our numbers are continuing to growing and the **NEED** is out there. My monthly MART reports track these numbers for us to follow. We do insist that masks be wore in order to ride on our van. Sam wears his mask always and keeps the van SPOTLESS for all our clients. We provide rides to doctors appointments, this is priority, as well as shopping in town every day. We are continuing shopping trips to Market Basket of Littleton and Walmart of Lunenburg. These added shopping trips have been very well received by our clients. We insist on following the social distancing protocol/masks to be worn on the van.
- I am continuing to help our clients sign up for their vaccines with new clinics opening up weekly. All of our Shot#1 clients were able to receive Shot #2 which I was so happy about. Also I am now fully vaccinated.

- We are continuing with our off site meal program and Meals on Wheels daily for those in need. We are delivering approximately 400+ meals per month to clients in Ayer. This number seems to be leveling out. We are only able to drop off for clients, door to door there is still NO contact.
- So far since CV19 began we have been able to offer what our clients need at NO Charge to anyone. Having been blessed with so many grants and donations we are able to make things happen for those in NEED!
 - Forth newsletter went to print and it seems to be most helpful with our folks to have this back out there to navigate with.
 - I have completed all paperwork and reports required for the month of May.
 - I have attended all meetings required on the Zoom Program.
 - I have been involved with Directors meeting across the state monthly also using the Zoom program.
 - We have been doing everything so differently for our folks but it is working. Services have not stopped for the Ayer COA just a "NEW NORMAL" with a very limited staff.
 - So as we move into the Spring months our CV19 way of life will continue. And I am looking forward to our FIRST COA event since CV19 began. Our COA Summer Fling BBQ with the Ayer Fire Department on Friday June 25, 2021. This will be held at the Fire House in the fresh spring air. It is limited to 60 folks and all must have a reservation in order to attend. So planning has already begun between both departments.
 - We are also now open for Appointments only with limited time spent. MASKS and social distancing are both in place in order to come into the Center. We are looking forward to

changes coming in June with new protocol rules from the state.
