During the month of October 2021 the Ayer Shirley Regional Emergency Communications Center logged 2327 Events, the Ayer Police Department accounting for 1235 of them. We assisted the Fire Department on 37 medicals and 15 other Fire Department related calls.

October was a relatively uneventful month for the Ayer Police Department, but am happy to report that we had a safe and successful return to Halloween (both on the actual date and the Downtown version). The Ayer PD assisted in making sure both events were safe by being visibly present at both.

Officers Michael Bourisk and David Curran have completed more than half of their Field Training and should be cleared for shift assignment in December.

The members of both the Ayer Police Department and the Ayer Shirley Regional Emergency Communications Center (ASRECC) have begun their regimented yearly in-service training programs. We were happy to partner with the Nashoba Park Assisted Living and receive great training from their staff on living with Dementia. Members of the ASRECC attended an FD/Communications orientation training, hosted by the Ayer Fire Department. We also began our yearly firearms qualifications, doing low light / night training, which hasn't been done in the agency for over 25 years! The Ayer Sportsman's Club was gracious enough to allow us the use of their indoor range and outdoor ranges. This is taught by our own in-house instructors, who have been trained by the MPTC in their strict curriculum.
