In personnel news, Recruit Officers Jake Minear and Alexia Surprenant are doing well at the Fitchburg State University Academy and have passed their half-way point. If all goes well they should be graduating September 9th.

On June 21st the police department was awarded accreditation status by the Massachusetts Police Accreditation Commission. The accreditation status is active for 3 years, when we will be re-assessed that we have been in compliance with all standards throughout the time span.

The Police Department submitted its 1st ever request for officer recertification with the POST Commission, for officers whose last name begins with "A-H". Officer certifications are valid for 3 years, when they will have to be recertified.

All employees completed their yearly in-service training. This isn't only an accomplishment for the officers being trained, it is also one for the training team who teach and/or track on-going training standards.
